<p>c) FUEL: The allowance is limited to the quantities contained in the standard tank of any vehicle, plus the amount contained in one approved portable canister with a maximum capacity of 10 liters. Note: The canister must contain the same type of fuel as that in the vehicle carrying it.</p>	<p>c) FUEL: The allowance is limited to the quantities contained in the standard tank of any vehicle, plus the amount contained in one approved portable canister with a maximum capacity of 25 liters. Note: The canister must contain the same type of fuel as that in the vehicle carrying it.</p>
<p>d) "VALUE ALLOWANCE": All goods purchased in Livigno, including those within the allowances mentioned in the other sections, must respect the following limits:</p> <ul style="list-style-type: none"> • travelers over 15 years old - 300 Euros • travelers under 15 years old - 150 Euros <p>Additionally, purchases must not be of commercial nature and must concern goods intended for the personal or family use of the travelers or meant to be given as gifts. The value allowance is personal and non-cumulative!</p>	<p>d) "VALUE ALLOWANCE": All purchased goods, including those falling within the allowances mentioned in sections a), b), and e), must respect the limit of 300 CHF per traveler. Additionally, purchases must not be of commercial nature and must concern goods intended for the personal or family use of the travelers or meant to be given as gifts. The value allowance is personal and non-cumulative!</p>
<p>e) OTHER PRODUCTS The commercial nature of purchases is excluded for the following products if made in these maximum quantities:</p> <p>SUGAR 10 kg COFFEE 2 kg MEAT AND MEAT-BASED PRODUCTS, MILK, AND DAIRY PRODUCTS 5 kg PERFUMES AND EAU DE TOILETTE .. 300/400 ml</p>	<p>e) OTHER PRODUCTS The following quantities of products can be imported duty-free:</p> <p>MEAT AND MEAT-BASED PREPARATIONS ... 1 kg GAME MEAT UP TO 300CHF BUTTER 1 kg OILS, MARGARINE AND OTHER FATS ... 5 lt/5kg SUGAR, COFFEE, CHEESE AND PARFUMES .
